Dear Mr. Sheppard:

The Oregon Public Works Emergency Response Cooperative Assistance Agreement is up for renewal. As stated on Page 5, the Agreement shall remain in effect for five years after the date a party executes the Agreement. Your agency's commitment to the agreement expires 2/19/2018.

The mutual aid agreement:

- Enables public works agencies to support each other during an emergency.
- Provides the mechanism for immediate response to the Requesting Agency when the Responding Agency determines it can provide the needed resources and expertise.
- Sets up the documentation needed to seek maximum reimbursement possible from federal agencies.

Public works agencies in Oregon may sign the agreement or cancel their participation as they wish. The Oregon Department of Transportation (ODOT) maintains the list of all parties to the agreement and sends an updated list to all agencies whenever an agency is added to or removed from the list. Any agency may cancel its participation by giving written notice. The list of current members and guidelines on the ODOT Maintenance and Operations Branch web page at

OREGON PUBLIC WORKS EMERGENCY RESPONSE
COOPERATIVE ASSISTANCE AGREEMENT

THIS AGREEMENT is between the government agencies (local, county, or state) that have executed the Agreement, as indicated by the signatures at the end of this document.

WITNESSETH:

WHEREAS, parties to this agreement are responsible for the construction and maintenance of public facilities such as street, road, highway, sewer, water, and related systems during routine and emergency conditions; and

WHEREAS, each of the parties owns and maintains equipment, and employs personnel who are trained to provide service in the construction and maintenance of street, road, highway, sewer, water, and related systems and other support;

WHEREAS, in the event of a major emergency or disaster as defined in ORS 40 1.025 (5), the parties who have executed this Agreement may need assistance to provide supplemental personnel, equipment, or other support; and

WHEREAS, the parties have the necessary personnel and equipment to provide such services in the event of an emergency; and

WHEREAS, it is necessary and desirable that this Agreement be executed for the exchange of mutual assistance, with the intent to supplement not supplant agency personnel;

WHEREAS, an Agreement would help provide documentation needed to seek the maximum reimbursement possible from appropriate federal agencies during emergencies;

WHEREAS, ORS Chapter 402.010 provides for Cooperative Assistance Agreement among public and private agencies for reciprocal emergency aid and resources; and

WHEREAS, ORS Chapter 190 provides for intergovernmental agreements and the apportionment among the parties of the responsibility for providing funds to pay for expenses incurred in the performance of the agreed upon functions or activities;

NOW THEREFORE, the parties agree as follows:

1. Request

If confronted with an emergency situation requiring personnel, equipment or material not available to it, the requesting party (Requestor) may request assistance from any of the other parties who have executed this Agreement.

2. Response

Upon receipt of such request, the party receiving the request (Responder) shall immediately take the following action:

- A. Determine whether it has the personnel, equipment, or material available to respond to the request.
- B. Determine what available personnel and equipment should be dispatched and/or what material should be supplied.
- C. Dispatch available and appropriate personnel and equipment to the location designated by the Requestor.
- D. Provide appropriate access to the available material.
- E. Advise the Requestor immediately in the event all or some of the requested personnel, equipment, or material is not available.

NOTE: It is understood that the integrity of dedicated funds needs to be protected. Therefore, agencies funded with road funds are limited to providing services for road activities, sewer funds are limited to providing services for sewer activities and so on.

3. Incident Commander

The Incident Commander of the emergency shall be designated by the Requestor, and shall be in overall command of the operations under whom the personnel and equipment of the Responder shall serve. The personnel and equipment of the Responder shall be under the immediate control of a supervisor of the Responder. If the Incident Commander specifically requests a supervisor of the Responder to assume command, the Incident Commander shall not, by relinquishing command, relieve the Requestor of responsibility for the incident.

4. Documentation

Documentation of hours worked, and equipment or materials used or provided will be maintained on a shift by shift basis by the Responder, and provided to the Requestor as needed.

5. Release of Personnel and Equipment

All personnel, equipment, and unused material provided under this Agreement shall be returned to the Responder upon release by the Requestor, or on demand by the Responder.

6. Compensation

It is hereby understood that the Responder will be reimbursed (e.g. labor, equipment, materials and other related expenses as applicable, including loss or damage to equipment) at its adopted usual and customary rates. Compensation may include:

- A. Compensation for workers at the Responder's current pay structure, including call back, overtime, and benefits.
- B. Compensation for equipment at Responder's established rental rate.
- C. Compensation for materials, at Responder's cost. Materials may be replaced at Requestor's discretion in lieu of cash payment upon approval by the Responder for such replacement.
- D. Without prejudice to a Responder's right to indemnification under Section 7.A. herein, compensation for damages to equipment occurring during the emergency incident shall be paid by the Requestor, subject to the following limitations:
 - 1) Maximum liability shall not **exceed** the cost of repair or cost of replacement, whichever is less.
 - 2) No compensation will be paid for equipment damage or loss attributable to natural disasters or acts of God not related to the emergency incident.
 - 3) To the extent of any payment under this section, Requestor will have the right of subrogation for all claims against parties other than parties to this agreement who may be responsible in whole or in part for damage to the equipment.
 - 4) Requestor shall not be liable for damage caused by the neglect of the Responder's operators.

Within 30 days after presentation of bills by Responder entitled to compensation under this section, Requestor will either pay or make mutually acceptable arrangements for payment.

7. Indemnification

This provision applies to all parties only when a Requestor requests and a Responder provides personnel, equipment, or material under the terms of this Agreement. A Responder's act of withdrawing personnel, equipment, or material provided is not considered a party's activity under this Agreement for purposes of this provision.

To the extent permitted by Article XI of the Oregon Constitution and by the Oregon Tort Claims Act, each party shall indemnify, within the limits of the Tort Claims Act, the other parties against liability for damage to life or property arising from the indemnifying party's own activities under this Agreement, provided that a party will not be required to indemnify another party for any such liability arising out of the wrongful acts of employees or agents of that other party.

8. Workers Compensation Withholdings and Employer Liability

Each party shall remain fully responsible as employer for all taxes, assessments, fees, premiums, wages, withholdings, workers compensation and other direct and indirect compensation, benefits,

and related obligations with respect to its own employees. Likewise, each party shall insure, self-insure, or both, its own employees as required by Oregon Revised Statutes.

9. Pre-Incident Plans

The parties may develop pre-incident plans for the type and locations of problem areas where emergency assistance may be needed, the types of personnel and equipment to be dispatched, and the training to be conducted to ensure efficient operations. Such plans shall take into consideration the proper protection by the Responder of its own geographical area.

10. The Agreement

- A. It is understood that all parties may not execute this Agreement at the same time. It is the intention of the parties that any governmental entity in the State of Oregon may enter into this Agreement and that all parties who execute this Agreement will be considered to be equal parties to the Agreement. The individual parties to this Agreement may be "Requestor" or "Responder's" as referred to in Section 1. and 2. above, to all others who have entered this Agreement.
- B. The Oregon Department of Transportation (ODOT) Maintenance and Operations Branch shall maintain the master copy of this Agreement, including a list of all those governmental entities that have executed this Cooperative Assistance Agreement. ODOT will make the list of participants available to any entity that has signed the Agreement. Whenever an entity executes the agreement, ODOT shall notify all others who have executed the Agreement of the new participant. Except as specifically provided in this paragraph, ODOT has no obligations to give notice nor does it have any other or additional obligations than any other party.
- C. This Agreement shall be effective upon approval by two or more parties and shall remain in effect as to a specific party for five years after the date that party executes this Agreement unless sooner terminated as provided in this paragraph. Any party may terminate its participation in this Agreement prior to expiration as follows:
 - 1) Written notice of intent to terminate this Agreement must be given to all other parties on the master list of parties at least 30 days prior to termination date. This notice shall automatically terminate the Agreement as to the terminating party on the date set out in the notice unless rescinded by that party in writing prior to that date.
 - 2) Termination will not affect a party's obligations for payment arising prior to the termination of this Agreement.

11. Non-exclusive

This Agreement is not intended to be exclusive among the parties. Any party may enter into separate cooperative assistance or mutual aid agreements with any other entity. No such separate Agreement shall terminate any responsibility under this Agreement.

Energy Conservation Program Customer Implementation Agreement for Non-Custom Projects at Existing Non-Residential Facilities

This Energy Conservation Program Customer Implementation Agreement (Agreement) is entered into on the date signed by the parties, below, by and between Columbia River PUD, 64001 Columbia River Highway, Deer Island, Oregon 97054 ("CRPUD"), and City of St. Helens ("Customer"), in order to set forth the terms and conditions under which CRPUD will pay financial incentives ("Incentive Award") to Customer under an energy conservation program established by Bonneville Power Administration (BPA). CRPUD and Customer may be referred to individually as "Party" or, collectively, as "Parties."

Recitals

- A. CRPUD has adopted a policy to obtain cost-effective resources, including energy conservation measures, in order to cost-effectively meet its customers' electric energy requirements;
- B. CRPUD is receiving funds and/or rate incentives through BPA to pay financial incentives for regionally cost-effective conservation measures;
- C. Customer is authorized to improve or upgrade the premises located at St Helens Public Works Building, 984 Oregon Street, St Helens, OR 97051; and
- D. The Parties wish to enter into this Agreement in order to set forth the terms and conditions under which CRPUD will pay Incentive Awards to Customer under an energy conservation program established by BPA.

The Parties hereby agree as follows:

1. Scope of Work. Customer shall install the energy conservation measures described in Attachment A in accordance with BPA's program requirements set forth in Attachment B, and any addenda thereto detailing measure recommendations, specifications, and/or additional requirements. All work under this Agreement shall be performed pursuant to applicable law and regulation.
2. Award of Funds. Only projects preauthorized in writing by CRPUD shall be eligible for inclusion in the calculation of any Incentive Award. Upon Customers compliance with the requirements of this agreement, which include: proper installation of the energy conservation measures by Customer (or its contractor) and verification and approval of the energy conservation measures by CRPUD; CRPUD shall pay Customer an estimated Incentive Award of \$1,240.00. This is an estimated amount; the actual Incentive Award calculation shall be subject to the actual measures installed and approved at the site.



3. Inspection of Facilities. Customer shall allow a representative of CRPUD on its premises to inspect the existing equipment before removal and to perform additional inspections as Customer's energy conservation measures are completed. Such inspections shall be performed at CRPUD's convenience during Customer's normal business hours. Any inspection by CRPUD shall not be, nor shall it be construed as, an acceptance by CRPUD of the performance of any of Customer's energy conservation measures.

4. Environmental Requirements. Customer shall develop and implement an appropriate plan to deal with all environmental issues in accordance with applicable legal requirements for the disposal and removal of its equipment and other related materials. Proper disposal of replaced equipment, materials, and any waste must be fully completed and verified in writing before any Incentive Award shall be paid by CRPUD.

5. Codes and Permits. Customer shall secure any necessary or required permits, and comply with all applicable federal, state and local codes or other requirements in the design and installation of all energy conservation measures. Where permits are required, the appropriate building code enforcement officials must approve the installation. Customer agrees to maintain all documents demonstrating compliance with this section in their files and have them available for review during normal business hours upon request by CRPUD.

6. Lien Releases. Customer shall secure the release of all liens from the contractors and suppliers, including all subcontractors and their suppliers, involved with the installation or performance of the energy conservation measures that are the subject of this Agreement. Written verification of all such releases shall be supplied to CRPUD prior to the payment of any Incentive Award.

7. Project Duration. Customer shall complete the project by June 30th, 2018. Any extension shall be granted only at CRPUD's sole discretion.

8. Use of Billing Information. CRPUD is authorized to provide all relevant monthly billing data for energy usage at the premises to BPA or its contractors for evaluation purposes for the period extending from twelve (12) months before the energy conservation measures are installed to the date two (2) years following the completed installation of those measures. Customer shall be responsible for repayment of any amounts paid by CRPUD under this Agreement should this billing information not be made available. Customer shall require a rental condition from all tenants that the monthly electrical billing information for their premises be supplied to BPA or its contractor for the same period. For existing tenants, Customer shall provide CRPUD with the requisite authority to request the release of this information directly from the tenants.

9. Disclaimer. Customer acknowledges that, due to the variability of energy use, it is not possible to accurately predict energy savings, and that by providing information regarding the benefits of energy savings strategies and by entering into this Agreement, CRPUD does not guarantee that energy savings will necessarily result from the activities and energy conservation measures performed under this Agreement.



10. Hold Harmless. Customer, on its behalf and that of its officers, employees, agents, assigns, and successors in interest, shall hold harmless, indemnify and defend, BPA, CRPUD, and their officers, employees, agents and assigns, from and against any and all causes of action, claims, damages and costs arising out of, or in any way connected with, the design, installation or performance of the energy conservation measures or the amount of financial assistance provided for the measures installed or performed under the provisions of this Agreement.

11. Legal Authority. The undersigned represent and warrant that they are the authorized representatives of the Party for which they have executed this Agreement, and that they have the requisite authority to execute this Agreement.

12. Failure to Meet All Measure Requirements. Failure to meet all requirements for the installation of the measures to be installed or performed under this Agreement will result in the reduction or elimination of Incentive Awards for such measures.

13. Merger of Attachments. Attachment A, Attachment B and the addenda thereto are hereby incorporated with and made a part of this Agreement.

14. Performance and Payment Security. Customer acknowledges that CRPUD is subject to a repayment obligation to BPA, or other funding entities, for the Incentive Award funds, or some portion thereof, should the energy conservation measures fail to achieve the results required under the terms and conditions of the BPA program or this Agreement. CRPUD shall have the right to demand, in its sole discretion and at any time, that Customer provide adequate performance and payment security for CRPUD's reasonable estimate of any remaining repayment obligation. Such security shall be in the form of a performance and payment bond, or such other instrument as CRPUD deems acceptable in its sole discretion. CRPUD shall have the right to withhold payment of any Incentive Award until such time as Customer has provided the security required under this section. The amount of the security shall be reassessed each year during which CRPUD is subject to a BPA repayment obligation and adjusted accordingly.

The Planning Commission meeting was called to order by Chair Al Petersen at 7:00 p.m. Chair Petersen led the flag salute.

Consent Agenda

Approval of Minutes

Commissioner Webster moved to approve the minutes of the October 10, 2017 Planning Commission meeting. Vice Chair Cary seconded the motion. Motion carried with all in favor. Commissioner Semling did not vote due to her absence from that meeting. Chair Petersen did not vote as per operating rules.

Topics From The Floor

Julie Stenberg was in the audience. She stated her interest in joining the Planning Commission. She interviewed last week for Chair Petersen's term, which ends on December 31, 2017.

Commission Term Expiration Discussion

City Planner Graichen asked if anyone would like to end their term with the Commission guilt-free. He explained that Stenberg's background makes her a very good fit for the Commission, which is not always the case with incoming applicants. Commissioner Hubbard noted that Stenberg has a background in real estate law and development, which would be great with the upcoming waterfront redevelopment. Councilor Carlson wanted to see if any commissioners were planning on leaving in the next year because of life changes or any other reasons. None of the commissioners volunteered to end their term early.

Chair Petersen asked if the City asked Stenberg to be on the Advisory Committee for the upcoming Riverfront Connector planning process. Graichen said not yet. Stenberg agreed to be on this Committee. Associate Planner Dimsho said she would add her to the list.

Commissioner Cohen said he sat in on the interview with Stenberg. He thinks she is a qualified candidate, which is rare, but he does not feel comfortable removing Chair Petersen because of his experience and tenure on the Commission. Commissioner Cohen likes the idea of having an alternate member for when commissioners are absent. The Commission would like to pursue this as an option. Graichen said he could research the alternate member option for specific rules (depending on the City Council's decision). He said it would take a text amendment to make it happen.

Stenberg said if she is unable to join the Commission at this time, she would be fine with volunteering in other ways for a few years until there is an opening in the future.

Commissioner Cohen moved to recommend to City Council to appoint Chair Petersen for another term. Commissioner Webster seconded the motion. Motion carried with all in favor.

Commissioner Cohen moved to recommend to City Council to have an alternate commissioner with Julie Stenberg serving this role. Commission Webster seconded the motion. Motion carried with all in favor.



Dedication of Open Space Discussion

Graichen explained that this topic is a result of the recently approved Emerald Meadows subdivision. He said the testimony during the City Council public hearing revolved around the fact that it was high density residential lots with little open space. Graichen explained the proposed guidelines and pros and cons for requiring open space dedication with subdivisions, as presented in the memo.

Chair Petersen suggested a Local Improvement District to fund the maintenance of the park, instead of a Homeowner's Association (HOA). Graichen said typically LIDs are based on a specific project and then disband once complete.

Commissioner Cohen said he likes the idea, but he is concerned about the term "open space." That term makes him think of wetlands that are overgrown. He thinks it should be an amenity for recreation that people can actually use. Commissioner Cohen further explained that if the City is going to impose an open space requirement, then it should be well-defined what amenities are provided on the open space. Commissioner Cohen said he is also concerned that if it is only the people within the development paying for it, then it should only be the people who live there who can use it. He asked how that would be enforced.

Commissioner Hubbard said he does not think one lot would be sufficient. He thinks it should be a square footage requirement based on the size of the subdivision. He also noted that City Council approved a zone change to higher density for the Emerald Meadows subdivision. He feels that was part of the reason for the testimony about the lack of open space during the public hearing.

Commissioner Lawrence said she has experience with shared open space. Her HOA maintains the open space, a gazebo, and a ramp down to the river. It is entirely fenced in. She is not sure the shared maintenance would work on a larger scale.

Commissioner Semling said that when all of the lots surround the open space with fencing around the perimeter, it makes people who do not live there hesitant to use the space. She also feels that at least two lots should have been required for a development as big as Emerald Meadows. Commissioner Hubbard said it should be a square footage requirement, not just a number of lots.

Vice Chair Cary said the open space should not be at the edge of the subdivision in an area that is simply not developable, otherwise it will get overgrown and unusable. Chair Petersen agrees; the lot should be well designed. Commissioner Cohen said if the City had a Parks and Recreation District, the District could take maintenance responsibility, instead of an HOA.

Chair Petersen suggested 25 lots and/or dwelling units as the trigger for the open space requirement, since that is what triggers a Transportation Impact Analysis. There was no consensus about this number. The Commission would prefer a square footage requirement instead of requiring a single lot dedication. Commissioner Semling does not think the open space requirement should apply to R10 zoning, since they have large lots and yard requirements. The Commission agreed.

Commissioner Cohen asked how the open space dedication would not overlap with park SDCs. Graichen said he would look into it.

Commissioner Hubbard feels there are more cons than pros with the blanket open space dedication requirement idea. However, he suggested that if there are parks nearby to the development, perhaps the developer can build a better connection to the existing park. Commissioner Webster agreed.

Graichen explained the likely remaining areas to be developed in the City using the exhibit in the memo. He said there are not many large developments remaining. Commissioner Webster does not think it is worth the hassle to develop the open space dedication requirement. Commissioner Cohen said there is only land available to develop five to six more large subdivisions, so he agrees.

Councilor Carlson said the open space dedication requirement seemed like a good idea during the Council meeting, but after hearing this discussion, she feels it might make more sense to have a "livability mitigation" requirement that can be flexible depending on the context of the development. Vice Chair Cary agrees. The Commission likes having a flexible standard for subdivisions that gives the City more power to apply conditions related to parks and open space. Dimsho suggested tying the conditions to the needs of the Parks & Trails Master Plan, so they are tangible improvements. Graichen said ultimately any conditions will have to be clear and objective. The Commission agreed to pursue this option instead of the open space dedication requirement.
