**Motion:** Upon Locke's motion and Conn's second, the Council unanimously appointed Lisa Brooke to the Arts & Cultural Commission. Her term will expire 9/30/2018.

#### Parks Commission (4-year terms)

■ John Brewington's and Elisa Mann's terms expires 12/31/2017. Both would like to be reappointed. John has served more than two terms. Elisa has not.

**Status:** A press release was sent out on October 10, 2017. We have received one application.

The deadline to apply is November 3, 2017.

**Recommendation:** Reappoint Elisa Mann to an additional 4-year term.

**Motion:** Conn moved to reappoint Elisa Mann to the Parks Commission. Her term will expire 9/30/2021. Locke seconded. Locke, Carlson, Conn, and Scholl in favor. Morten opposed. Motion carries.

Discussion. Council President Morten expressed that the Parks Commission did not make a recommendation at their last meeting. He would like to take it back to the next Parks Commission meeting for discussion.

**Motion:** Upon Locke's motion and Conn's second, the Council unanimously rescinded the motion to allow for further clarification from the Parks Commission.

# **Council Reports**

# Mayor Scholl reported...

Spirit of Halloweentown was overall a huge success. The businesses all thrived. Need to start early planning for next year. It's the 20-year reunion since the movie was filmed.

#### Councilor Locke reported...

- Spirit of Halloweentown has gotten bigger. He would like to talk about the next steps and how big they want it to be at the Council retreat. People come from all over the country. He would like to see a draw for them to return year after year.
- Chief Moss is not in attendance. He distributed an email to begin discussions about recruitment. What can we do to draw officers here and retain them? One thing is the importance of them living in the City. He would like to discuss it further at the retreat. Walsh confirmed that topic is included on the agenda.

#### Councilor Carlson reported...

- The Youth Council Hallowteen dance turned in almost 50 pounds of food.
- Youth Council helped with Elf on the Shelf last year. Because of trademarks, they are considering a snowman this year. Businesses have already expressed interest.
- Harvey and Vicky Bilton's family cleaned out all the flower beds and bark dusted in front of the Library.
- Youth Council member David is here to give a report.

## **Councilor Conn** reported...

- She and Mayor Scholl attended Trunk-or-Treat at the Police Department yesterday. She asked the Youth Council to consider participating next year. It was a very successful event.
- Interviews for police officer will take place in a couple weeks.

- Scarecrow contest awards will be given at the next meeting.
- She appreciates what the Bilton's did at the Library. Councilor Locke added that they also volunteer their building for the Hallowteen dance at no charge. Mayor Scholl asked staff to prepare a thank you note for his signature, on behalf of the Council.

# Council President Morten reported...

- The Council retreat will be exciting.
- He acknowledged Youth Council member David for being in attendance. He thanked Locke and Carlson for encouraging their attendance.
- Locke made a great point about managing Spirit of Halloweentown. Staff is doing a great job but is way understaffed for the needs. He drove through Sandy on Tuesday afternoon. There were lots of families trick-or-treating the commercial businesses. It had to be an organized event. We're one of the only cities in Oregon with a festival in October. The riverfront development will solve the issues we're having with Spirit of Halloweentown by bringing in hotels, commercial businesses, and livable areas.
- Parks Commission member Phillip Roddy recently passed away. He has been a public servant for most of his life. He worked with the Lions Club to donate 50 trees to the Parks Department.
- Reminder for Council to do evaluations. They are due by the end of the year.

## Youth Council Member David reported...

- The Hallowteen dance went smooth. Attendees had fun. The timing could have been shortened and a better selection of songs would have helped.
- He and Councilor Carlson talked about meeting to plan upcoming events.
- Councilor Carlson asked if the Council would like to hear feedback from Youth Council about Spirit of Halloweentown activities. Council concurred.
- Youth Council will have a get-together in December to promote membership.
- Mayor Scholl told David that Youth Council has the full support of City Council.
- It was great to be here. He learned a couple things.

Council has a goal to do live web cameras. He received a response that the contact was not interested in working with the City. After talking to the County and I.T., he asked if the Council would be interested in the City taking this on our own. It would cost between \$300 – 700 to purchase a camera, wiring, and technical assistance. Councilor Locke thinks I.T. staff is capable. He would like to see good quality cameras used. Consensus of Council to move forward doing it in-house.

# City Administrator Walsh reported...

- He participated in the Columbia County Economic Team panel last week. Local economic development, including tourism events were discussed.
- Portland Spirit passengers were excited about stopping at the docks. He suggests upgrades to the docks to allow commercial vessels. It is part of economic development.
- The League of Oregon Cities (LOC) has eight policy committees. He would like to serve on the Community Development or Water/Wastewater committees, as they would benefit the City. He submitted an application yesterday. No objections from Council.
