#### **Invitation to Citizens for Public Comment**

•<u>Steve LeSollen</u>. He is in the process of cleaning up his property. The problem has always been finance related. Bill Blank of Habitat for Humanity and Diane Dillard have both stepped up to help. With their help, he is able to get the clean-up going. He asked the Council to allow him to put a dump box on the street for five days. He has already gotten a lot done. People from a church came out to help as well. Five dump loads have already left the property. He has done more now than ever in the past.

Council concurred with allowing Steve to put a dump box in the right-of-way for the five requested days, reminding him to only work between the hours of 7 a.m. - 10 p.m.

Interim Public Works Co-Director Sheppeard gave a drop box permit application to Steve to complete and return to City Hall.

\*Joe Mauck. He is the Building Construction and Drafting teacher at St. Helens High School. There is an opportunity for a grant with the Oregon Department of Education. They are seeing the need to put the technical services back into schools. He reviewed a presentation on the proposed construction series remodel. Twenty-percent of Business Licenses in the City are construction related. The program would begin at the middle school level to educate and begin working with juniors and seniors. Part of the grant would involve an Offsite Renovations class in high school. They would purchase a foreclosed home. The class would perform an initial market analysis, determine the greatest return on investment, apply for permits and perform the work, except for electrical and plumbing. About 75% of the construction industry involves renovations. He has spoken with the Planning and Building Departments and they are both on board. Other classes would be included in the program as well; such as Natural Resources, Drafting, Marketing, Math and Art. Joe has contacted local contractors to put together an advisory board and provide internship opportunities.

Council President Morten expressed his excitement with the program. This is very encouraging for the community. There are two local scholarship opportunities to be aware of; the Voc-Ed scholarship offered by Rotary and the Chance to Become scholarship offered by Columbia Learning Center.

Joe said the grant would cover the cost to purchase two foreclosed homes. They have a year to complete the project. The good thing is that they could sell at any time.

Councilor Conn is impressed with the program.

#### **Bicycle & Pedestrian Commission Annual Report**

Bicycle & Pedestrian Commission member Paul Barlow was in attendance to give a report.

- Continuing the Annual Safety Assembly at Lewis & Clark and McBride Elementary Schools.
  - Handed out 82 helmets last year.
- Involved in the 4<sup>th</sup> of July Bicycle Parade.

- Volunteered to help kids decorate their bikes and provide safety along the parade route.
- A couple of members are involved in the Ford Leadership group assisting in bringing a century bicycle event to Columbia County.
- Held fundraisers to raise money for helmets and bicycle and pedestrian events, such as the fundraiser at Burgerville.
- Active part of the parks and trails master plan update. Made recommendations to the Parks Commission.
- Applied to the League of American Bicyclists requesting that the City of St. Helens be recognized as a bicycle friendly community.
- City Hall has posted a Bike Friendly sign. He was happy to see that. The Library and Chamber are interested as well.
- There are some lighting concerns that they recognized.

Chief Moss said the Police Department has a lot of bike-related materials for kids. He asked if Paul could use them for his event. Paul would really appreciate that. He will pick them up. They will work together on purchasing helmets with funds from a dedicated account.
