Qualifications for Candidacy

Requirements:

- 18 years of age or older.
- Registered to vote in Oregon.
- Must have resided within the city limits of St. Helens during the 12 months immediately preceding the election.

¹ Oregon Constitution, Article II

Section 2. Qualifications of electors.

(1) Every citizen of the United States is entitled to vote in all elections not otherwise provided for by this Constitution if such citizen:

(a) Is 18 years of age or older;

(b) Has resided in this state during the six months immediately preceding the election, except that provision may be made by law to permit a person who has resided in this state less than 30 days immediately preceding the election, but who is otherwise qualified under this subsection, to vote in the election for candidates for nomination or election for President or Vice President of the United States or elector of President and Vice President of the United States; and

(c) Is registered not less than 20 calendar days immediately preceding any election in the manner provided by law.

(2) Provision may be made by law to require that persons who vote upon questions of levying special taxes or issuing public bonds shall be taxpayers.

How to File

The following manuals will guide you through the process to run for St. Helens City Council:

Step 1. Register* Your Campaign Committee:

Prospective candidates shall file a Candidate's Statement of Organization form (SEL 220) with the Oregon Secretary of State's Elections Division.

This filing must take place within three (3) business days of receiving the first contribution or making an initial expenditure.

These filings are done electronically and additional instructions can be accessed at https://sos.oregon.gov/elections/Pages/orestar.aspx. From this website, you can login and register with ORESTAR. For additional information, contact the Oregon State Elections Division at (503)986-1518.

o <u>SEL 220 Statement of Organization</u>

*Note: A candidate is <u>not</u> required to establish a campaign account, file a Statement of Organization, or file contribution and expenditure reports, if <u>ALL THREE</u> of the following conditions are met:

- 1. The candidate serves as the candidate's own treasurer;
- 2. The candidate does not have an existing candidate committee; AND
- 3. The candidate does not expect to receive or spend more than \$750 during a calendar year.

Step 2. Two Options for Filing for Candidacy:

Nomination petitions and declarations of candidacy for City Council shall clearly indicate which position for the candidacy that corresponds to a City Council position that is to be filled in this general election. Councilors are elected by popular vote. We no longer use position numbers.

Option 1 - Candidates Filing by Declaration

Per City of St. Helens Municipal Code, you have the option of filing a \$50.00 fee in lieu of obtaining signatures on a petition. Please make checks payable to "**City of St. Helens**." You may also pay your Candidate Filing Fee online at

<u>https://www.municipalonlinepayments.com/sthelensor/easypay</u>. Remember, you must indicate on your form whether you are filing for the Mayor or a Councilor position. Complete the online form below and file with the City Elections Officer.

Option 2 - Candidates Filing by Petition

The petition form (SEL 121) must be approved by the City Elections Officer before you begin to gather signatures. The general information on the top should be completed before submitting to the Elections Officer. After your petition is approved, the City Elections Officer will return the form to you to begin gathering signatures. Copies of this form should be made and each sheet numbered before circulation.

After receiving approval from the City Elections Officer, circulate the approved petition (SEL 121) for signatures. St. Helens candidates must collect **64 valid signatures** to place a candidate on the ballot. *It is recommended that you collect more than the required number of signatures.* Please note that a person cannot sign a nomination petition unless they are already registered to vote in Columbia County residing in one of the three precincts in the City of St. Helens.

Remember, you must indicate on your forms whether you are filing for the Mayor or a Councilor position. Complete the two forms listed below and file them with the City Elections Officer.

Note: If you are filing by petition, you must complete and submit Form SEL 338 when submitting the signatures sheets to the City Elections Officer.

Step 3. File Your Completed Materials:

City filing deadline: 4:00 p.m. on August 16, 2024

Please submit all required forms and fees by this deadline, including the Certification of Qualified Elector/Residency form. You may submit forms in person, by mail, fax, or by scanning/emailing.

If mailing, faxing, or emailing, please confirm with the City Elections Officer that your materials have been received.

Step 4. Follow Campaign Finance Reporting Requirements:

Please review the *Campaign Finance Manual* for instructions and a schedule of filing deadlines. Campaign Finance forms are filed with the Secretary of State's Elections Division. All candidates are required to have a dedicated campaign bank account if they receive contributions or make expenditures over \$750 for the entire calendar year.

If you do not expect to receive a total of more than \$3,500 or spend a total of more than \$3,500 for an entire election, you may file a *Certificate of Limited Contributions and Expenditures* (PC 7). If at any time during the election, the total expenditures or contributions exceed \$3,500, you must file detailed contribution and expenditure reports.

Campaign Sign Regulations



SIGNS AND POLITICAL CAMPAIGNS IN THE CITY OF ST. HELENS

Political signs do not require a Sign Permit from the City, but are required to comply with the following standards

- Maximum size: 32 square feet.
- Maximum height: 8 feet.
- Time period allowed: 120 days before a public election or the time the election is called, whichever is earlier, to five days after the public election.
- Must be on private property (<u>not allowed within a public right-of-way</u>). Please get consent from the landowner before placing the sign on a property.

In addition to the regulations above, the following is prohibited:

- Illumination of political signs.
- Any political sign within a public right-of-way or on City owned property.
- Any political sign that may be confused with or construed as a traffic control device, or which hides a traffic control device from view.
- Any political sign that will obstruct access to any fire escape or other entrance/exit from a building or exit corridor.
- Any political sign that could impede vehicular or pedestrian traffic on any street, alley, sidewalk, bikeway or similar travel way.
- Any political sign attached to a tree or a plant, a fence or a utility pole.
- Any sign that violates clear vision rules (Chapter 17.76 St. Helens Municipal Code). Basically this means blocking visibility at intersections (including driveways).

Political signs erected contrary to City regulations may be removed by the City with or without notice. Noncompliant signs may also result in violations to be remedied in the St. Helens Municipal Court.

The standards explained above apply to what are typically considered "political signs." There are many more sign regulations for permanent and temporary signs, but they generally apply to signs intended for other uses. For more information about the City's sign regulations please contact the City Planning Department or review Chapter 17.88 of the St. Helens Municipal Code online, at City Hall or at the Library.
