- Bidders must be listed on the **Plan Holders List** for bid to be considered valid. A cost of \$10 is required to be added to Plan Holders List if bid documents are downloaded. You can pay by check or with credit card by phone or cash in person.

- Emailed or Faxed bids will not be accepted.
